

**RESOLUTION NO. 02-2022**

**A RESOLUTION TO APPROVE A CONTRACT WITH J.H. WRIGHT ASSOCIATES TO COMPLETE THE WATER DEPARTMENT SCADA SYSTEM, INTERGRATING WELL #1 WITH WELL #2 AND WELL #3.**

WHEREAS the SCADA System is a very important element to efficiently operate and maintain the Town's water system including monitoring pumps, motors, tanks, valves, and chlorination of each of the water supply facilities; and

WHEREAS the SCADA system is currently installed on Well #2 and Well #3; and

WHEREAS completing the SCADA system allows an efficient way to monitor chlorinating, and the water tank levels that affects the towns water pressure; and

WHEREAS the SCADA system project would be complete by integrating Well #1; and

WHEREAS J.H. Wright Associates installed the previous SCADA system for Well #2 and Well #3 and are familiar with the town's water system; and

WHEREAS a quote of \$6,008.40 has been received by J.H. Wright & Associates attached hereto as Exhibit "A" and incorporated by reference, and was found to be agreeable in completing the SCADA system, that integrates all three water facilities;


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF MALVERN that the town enter in a contract with J.H. Wright & Associates for completion of the SCADA system, as set forth on Exhibit "A" in the amount of Six Thousand and Eight Dollars and Forty Cents (\$6008.40).

BE IT FURTHER RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALVERN that the Municipal Clerk be directed to use federal American Rescue Plan Act funds for the SCADA system project as established by the federal program as being an eligible investment in the Water, Sewer and Broadband infrastructure.
