RESOLUTION NO. 15-2023

**A RESOLUTION ADOPTING A TRANSPORTATION PLAN
PURSUANT TO THE REBUILD ALABAMA ACT 2019-2 FOR THE
TOWN OF MALVERN FISCAL YEAR 2023/2024**

WHEREAS, the Alabama legislature in Act. No. 2019-2 adopted the Rebuild Alabama Act;

WHEREAS, the Rebuild Alabama Act provides for an allocation among the municipalities of the state on the basis of the ratio of population of each municipality to the total population of all municipalities of the state a portion of the additional taxes levied under the Act to be used for transportation infrastructure, improvement, preservation and maintenance;

WHEREAS, the Act provides that the municipal governing body of the City of Southside shall adopt an annual Transportation Plan no later than August 31st each year which shall provide a detailed list of projects for which expenditures are intended to be made in the next fiscal year and shall be based upon an estimate of the revenues anticipated from the fund in which the additional revenue is deposited during the next fiscal year; and


WHEREAS, the Act further provides that any such funds shall be used only for the maintenance, improvement, replacement, and construction of roads and bridges maintained by the Town of Malvern and such other uses as are defined in the Act.


NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Malvern as follows:

1. The Town Council of the Town of Malvern hereby passes this Resolution as its Transportation Plan submitted in compliance with the Rebuild Act, Act No. 2019-2.
2. Pursuant to the 2019-2 Act, the State of Alabama estimated the Town of Malvern to receive an anticipated allocation from the Rebuild Alabama Act fund for the 4th fiscal year (FY23/24) of approximately \$27,000.00
3. Pursuant to the Act, the Town anticipates expending funds received in part or in whole to fund any of the following listed projects on attached FY 2024 Town of Malvern Transportation Plan.
